



CBDT ANNOUNCED THAT 'ANNEXURE II' TO FORM 34E, WOULD BE APPLICABLE TO 'NOTIFIED RESIDENTS' WHO SEEKS ADVANCE RULINGS

*Notification No. 53/2023 (F. No. 370142/62/2021-TPL)
26th July, 2023*

Via Notification No. 53/2023, dated July 27, 2023, the CBDT issues a correction to Notification No. 37/2023, dated June 12, 2023, which announced new forms under the Advance Rulings regime.

The present Notification adds Annexure II to Form No. 34E, which was required to be used for requesting an Advance Ruling by a class of residents made aware by the Central Government. Annexure II calls for the applicants to provide a "Statement.
